Full Electric Vehicle Level 3 Charger Incentive Program



Marshfield Utilities offers an incentive to encourage charging for electric vehicles (EV). If you are a Marshfield Utilities Customer, you may be eligible for a \$4000 incentive toward a Level 3 Electric Vehicle charger.

Eligibility:

- Have purchased and installed a Level 3 Electric Vehicle charger
- Have all necessary Electric Infrastructure to Safely operate the charger
- Marshfield Utilities electric customer whose account is in good standing
- MU may inspect premises to verify the presence of any electric infrastructure required for the applicable level of charging and ownership of a Level 3 Charger

How to Apply:

- Applicant must meet all eligibility conditions and complete the application form (reverse side).
- Attach:
 - o receipt for the Electric Vehicle charger
 - receipt for installation costs (If no installation cost write zero in charger information section of the application)
